Hotel Union and Hotel Industry of Hawaii Pension Plan

This is a summary of the annual report for the Hotel Union and Hotel Industry of Hawaii Pension Plan; Employer Identification Number: 99-6024339, for the plan year beginning on August 1, 2007 and ending on July 31, 2008. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the plan are provided by a Trust. Plan expenses were \$\frac{\\$19,954,512}{\}\$. These expenses included \$\frac{\\$1,953,484}{\}\$ in administrative expenses, \$\frac{\\$18,001,028}{\}\$ in benefits paid to participants and beneficiaries. A total of \$\frac{13,227}{\}\$ persons were participants in or beneficiaries of the Plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the Plan was \$321,356,755 as of July 31, 2008, compared to \$346,386,868 as of August 1, 2007. During the Plan year, the Plan experienced a decrease in its net assets of \$25,030,113. This decrease includes unrealized appreciation or depreciation in the value of the Plan's assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The Plan had total income of -\$5,075,601, including employer contributions of \$13,059,080, gains of \$14,270,989 from the sale of assets and earnings from investments of -\$32,582,916.

MINIMUM FUNDING STANDARDS

An actuary's statement shows that enough money was contributed to the Plan to keep it funded in accordance with the minimum funding standards of ERISA.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
