For D.K. Abe, Inc., dba Precision Vision, the only co-payments that you will be required to pay will be for trifocal and progressive multifocal lenses, non-standard lenses, frames not within the group of frames designated as being fully covered, contact lenses, and non-covered items.

For CNS Optics Hawaii, Inc., dba Shades of California, the only co-payments that you will be required to pay will be for eyeglasses, contact lenses, and non-covered items.

You are still free to go to any licensed vision care provider of your choice and receive the Trust's allowance for covered services and supplies. However, by receiving services and supplies from a participating provider, you limit your out-of-pocket cost for covered services. For a complete list of participating vision care providers, contact the Hawaii Teamsters Health and Welfare Trust Office.

REMINDER

All vision claims must be filed within 90-days of the date of service.
